## Objectives and investment policy

### Objectives

The fund aims to produce long term capital appreciation for investors.

### Investment Policy

The fund invests in fixed income or debt securities which are denominated primarily in USD and Asian currencies and issued by companies, governments, quasi-governments, government agencies or supranationals in the Asian region.

The Asian countries include but are not limited to China (including Hong Kong SAR and Taiwan), South Korea, India, Thailand, Malaysia, Singapore, Indonesia, the Philippines, Pakistan and Vietnam.

Financial derivatives may be used to achieve the investment objective, reduce risk and for more efficient management of the fund. Financial derivatives are instruments whose prices are dependent upon or derived from one or more underlying assets.

The fund allows the Investment Manager to make discretionary choices when deciding which investments should be held in the fund, in accor-

dance with the fund's objectives and investment policy.

**Benchmark:** The fund is actively managed with reference to the benchmark, JACI Investment Grade Total Return Index, for performance comparison purpose.

The fund does not try to replicate this benchmark and freely selects the securities that it invests in. The deviation from this benchmark can be material.

During periods of market volatility, the Investment Manager will have the discretion to manage the fund in closer alignment with the benchmark as it varies the risk it takes against the index.

The fund's base currency is USD.

The currency of the share class is USD.

Investors may redeem shares on demand. Dealing in shares is carried out on each bank business day in Luxembourg and Singapore.

These shares are distribution shares. Income and capital gains may be distributed.

### What does this risk & reward indicator mean?

- This share class is classified in category 3 because the value of the share may be subject to medium variations and consequently the risk of loss and the opportunity of gain may be moderate.

### Which materially relevant risks are not adequately captured by the risk & reward indicator?

- **Operational risk:** Failures or delays in operational processes may affect the fund negatively.

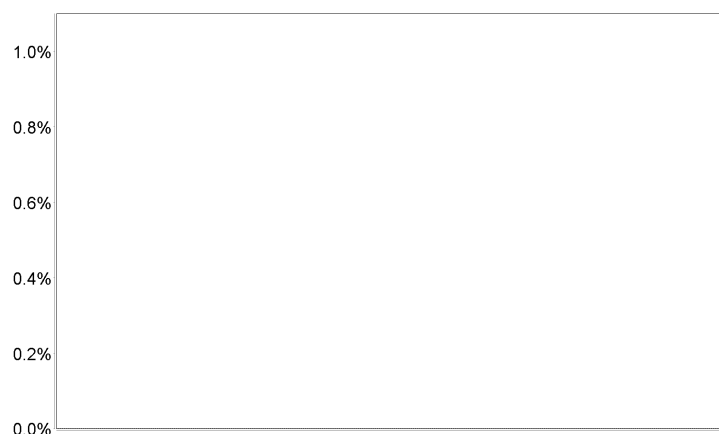
