# What is this product?

#### Type

This product is an investment fund.

### **Objectives**

**Investment objective** The fund aims to generate long term capital appreciation for investors.

**Investment policy** The fund invests in fixed income or debt securities denominated primarily in USD and Asian currencies, issued by companies, governments, quasi-governments, government agencies or supranationals in the Asian region.

The Asian countries include but are not limited to China, (including Hong Kong SAR and Taiwan), South Korea, India, Thailand, Malaysia, Singapore, Indonesia, the Philippines, Pakistan and Vietnam.

The fund may also invest up to 20% of the fund's Net Asset Value in perpetual bonds (including contingent convertible securities).

The fund may invest in money market instruments, money market funds, term deposits, bank deposits and other eligible liquid assets for treasury purposes and in case of unfavourable market conditions.

The fund may hold up to 20% of its Net Asset Value in ancillary liquid assets (bank deposits at sight, such as cash held in current accounts). Under exceptionally unfavourable market conditions and if justified in the interest of the investors, the fund may temporarily invest up to 100% of the fund's Net Asset Value in assets referred in these two last paragraphs of this section.

Benchmark The fund is actively managed with reference to the benchmark, "JACI Investment Grade Total Return Index", for performance comparison purposes. The fund does not try to replicate this benchmark and freely selects the securities that it invests in. The deviation from this benchmark can be material. During periods of market volatility, the Investment Manager will have the discretion to manage the

fund in closer alignment with the benchmark as it varies the risk it takes against the index.

For currency hedged Share Classes (if any), the benchmark will be hedged to the Share Class currency.

**Derivatives** The fund may employ financial derivative instruments for hedging, efficient portfolio management and investment purposes.

Currency The fund's base currency is USD.

**Redemption and Dealing** Investors may redeem shares on demand. Dealing in shares is carried out on each bank business day in Luxembourg and Singapore.

**Distribution Policy** This share class accumulates income received from the fund's investments, meaning the income is kept in the fund and the value is reflected in the price of the share class.

#### Term

There is no maturity date on this product.

#### Intended retail investor



# What are the risks and what could I get in return? Risks



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 2 out of 7, which is a low risk class.

#### Performance scenarios

# What happens if Lemanik Asset Management S.A. is unable to pay out?

The Management Company has no obligation to pay out since this fund does not contemplate any such payment being made and you would still be paid in case of a default from the Management Company. The fund's assets are held with BNP Paribas, Luxembourg Branch, a separate company, the Depositary, so the fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the fund. The Depositary will also be liable to the fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). If the fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. There is no compensation or guarantee scheme protecting you from a default of the Depositary.

#### What are the costs?

#### Costs over time
