### What is this product?

### **Type**

This product is an investment fund.

### **Objectives**

**Investment objective** The fund aims to generate long term capital appreciation.

**Investment policy** The fund invests primarily in China "A" Shares listed on PRC Stock Exchanges through the Investment Manager's QFI license and stocks listed on the Hong Kong Stock Exchange.

The investment universe will include, but is not limited to, exchange traded funds, listed warrants, index futures, securities investment funds, listed onshore bonds, money market funds, cash and other financial instruments qualifying as QFI Eligible Securities.

The fund may invest in money market instruments, money market funds, term deposits, bank deposits and other eligible liquid assets for treasury purposes and in case of unfavourable market conditions.

The fund may hold up to 20% of its Net Asset Value in ancillary liquid assets (bank deposits at sight, such as cash held in current accounts). Under exceptionally unfavourable market conditions and if justified in the interest of the investors, the fund may temporarily invest up to 100% of the fund's Net Asset Value in assets referred in these two last paragraphs of this section.

**Benchmark** The fund is actively managed without reference to a benchmark.

**Derivatives** The fund may employ financial derivative instruments for hedging and efficient portfolio management purposes.

Currency The fund's base currency is USD.

**Redemption and Dealing** Investors may redeem shares on demand. Dealing in shares is carried out on each bank business day in China, Hong Kong, Luxembourg and Singapore.

**Distribution Policy** This share class accumulates income received from the fund's investments, meaning the income is kept in the fund and the value is reflected in the price of the share class.

#### Term

There is no maturity date on this product.

### Intended retail investor

This product is intended for investors who are seeking long term growth potential offered through investment in equities and are comfortable with the risks of an equity fund which invests primarily in China "A" Shares listed on PRC Stock Exchanges through the Investment Manager's QFI licence and stocks listed on the Hong Kong Stock Exchange.



# **Risks**



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

### Performance scenarios

# What happens if Lemanik Asset Management S.A. is unable to pay out?

The Management Company has no obligation to pay out since this fund does not contemplate any such payment being made and you would still be paid in case of a default from the Management Company. The fund's assets are held with BNP Paribas, Luxembourg Branch, a separate company, the Depositary, so the fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the fund. The Depositary will also be liable to the fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). If the fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. There is no compensation or guarantee scheme protecting you from a default of the Depositary.
