## What is this product?

### Type

This is an open-ended investment fund, part of Fullerton Lux Funds, a SICAV incorporated in Luxembourg under Part I of the Luxembourg law of 17 December 2010.

### Objectives

**Investment objective** The fund aims to generate long term capital appreciation for investors.

**Investment policy** The Investment Manager seeks to achieve the objective of the fund by investing primarily in investment grade, unrated or rated non-investment grade fixed income or debt securities, including convertibles that are, denominated in USD and Asian currencies or are issued by companies, governments, quasi-governments, government agencies or supranationals in the Asian region.

The Asian countries may include but are not limited to China, (including Hong Kong SAR and Taiwan), South Korea, India, Thailand, Malaysia, Singapore, Indonesia, the Philippines and Vietnam.

The investment universe will include, but is not limited to government and corporate bonds, interest rate futures, credit default swaps (CDS), CDS indices, foreign exchange (FX) derivatives, convertible bonds, UCITS and other eligible UCIs and exchange traded funds (ETFs).

The fund may also invest (i) up to 15% of the fund's Net Asset Value in contingent convertible securities (including perpetual contingent convertible securities) and/or (ii) up to 15% of the fund's Net Asset Value in perpetual bonds (excluding perpetual contingent convertible securities).

The fund's investment in onshore RMB (CNY) bonds may include bonds traded in both the CIBM and PRC Stock Exchanges, made through QFI, Bond Connect, direct CIBM program, and/or any other means as may be permitted by the relevant regulations from time to time, for up to 20% of the fund's Net Asset Value.

The fund may invest in money market instruments, money market funds, term deposits, bank deposits and other eligible liquid assets for treasury purposes and in case of unfavourable market conditions.

The fund may hold up to 20% of its Net Asset Value in ancillary liquid assets (bank deposits at sight, such as cash held in current accounts).

Under exceptionally unfavourable market conditions and if justified in the interest of the investors, the fund may temporarily invest up to 100% of the fund's Net Asset Value in assets referred in these two last paragraphs of this section.

**Benchmark** The fund is actively managed without reference to a benchmark.

**Derivatives** The fund may employ financial derivative instruments for hedging and efficient portfolio management purposes only.

**Currency** The fund's base currency is USD.

**Distribution Policy** These shares are distribution shares. Income and capital gains may be distributed.

### Term

There is no maturity date on this product.

### Intended retail investor

This product is intended for investors who are seeking long-term capital gain, are looking for a fixed income fund which provides exposure to the Asian region and are comfortable with the greater volatility and risks of a fund which invests primarily in unrated or non-investment grade fixed income or debt securities denominated primarily in USD and Asian currencies.

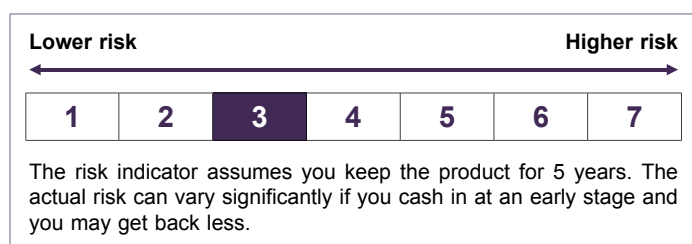

**Redemption and Dealing** For Class A-1 (SGD) Hedged Distribution: 2nd and 15th of each month (or if the 2nd or the 15th is not a Business Day, then the Business Day immediately following the 2nd or 15th (as the case maybe)), where such Business Day does not fall within a period of suspension of calculation of the Net Asset Value per Share of the fund, and such other day as the Directors may decide from time to time. In respect of this fund, "Business Day" means a weekday on which banks are normally open for business in Luxembourg and Singapore.

## What are the risks and what could I get in return?

### Risks

## Performance scenarios

## What happens if FundSight S.A. is unable to pay out?

The Management Company has no obligation to pay out since this fund does not contemplate any such payment being made and you would still be paid in case of a default from the Management Company. The fund's assets are held with BNP Paribas, Luxembourg Branch, a separate company, the Depository, so the fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depository's insolvency, or its delegates, the fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depository is required by law and regulation to segregate its own assets from the assets of the fund. The Depository will also be liable to the fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). If the fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. There is no compensation or guarantee scheme protecting you from a default of the Depository.
