Objectives and investment policy

Objectives

The fund aims to generate long term capital appreciation.

Investment Policy

The fund invests primarily in China "A" Shares listed on PRC Stock Exchanges through the Investment Manager's QFI license and stocks listed on the Hong Kong Stock Exchange.

The investment universe will include, but is not limited to, exchange traded funds, listed warrants, index futures, securities investment funds, listed onshore bonds, money market funds, cash and other financial instruments qualifying as QFI Eligible Securities.

The fund may employ financial derivative instruments for hedging and efficient portfolio management purposes.

The fund may invest in money market instruments, money market funds, term deposits, bank deposits and other eligible liquid assets for treasury purposes and in case of unfavourable market conditions.

The fund may hold up to 20% of its Net Asset Value in ancillary liquid assets (bank deposits at sight, such as cash held in current accounts). Under exceptionally unfavourable market conditions and if justified in the interest of the investors, the fund may temporarily invest up to 100% of the fund's Net Asset Value in assets referred in these two last paragraphs of this section.

Benchmark: The fund is actively managed without reference to a benchmark.

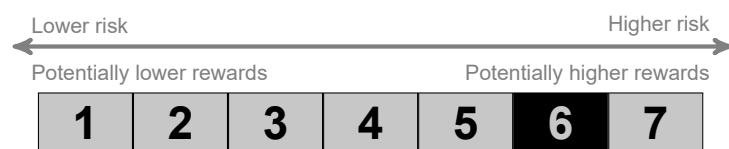
The fund's base currency is USD.

The currency of the share class is USD.

Investors may redeem shares on demand. Dealing in shares is carried out on each bank business day in China, Hong Kong, Luxembourg and Singapore.

This share class accumulates income received from the fund's investments, meaning the income is kept in the fund and the value is reflected in the price of the share class.

What does this risk & reward indicator mean?

Which materially relevant risks are not adequately captured by the risk & reward indicator?

- Operational risk:** Failures or delays in operational processes may affect the fund negatively.

The fund is also subject to changes in China's foreign exchange control and repatriation policies which may affect the liquidity and performance of the fund.

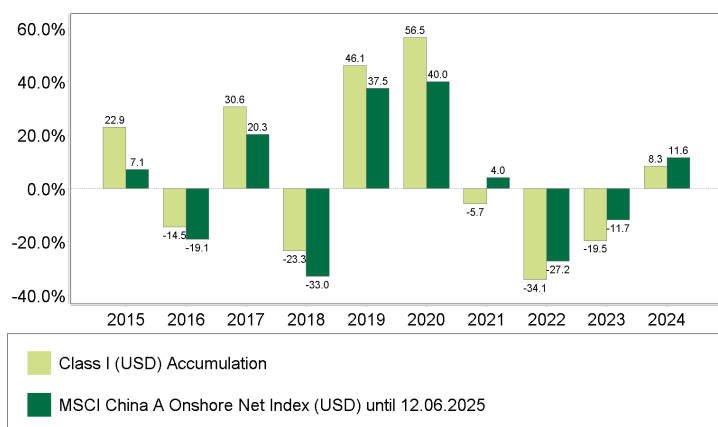
The ongoing charges figure shown here is based on annual expenses for the period from 1 April 2024 to 31 March 2025. The ongoing charges may vary from year to year.
