<b>Market and Credit Risks</b>	
<ul style="list-style-type: none"> <li>• <b>You are exposed to the risk of investing in emerging and less developed markets.</b> The legal, judicial and regulatory infrastructure of such markets is still developing and there is much legal uncertainty.</li> <li>• <b>You are exposed to political, regulatory and economic risks.</b> Economic and/or political instability could lead to legal, fiscal and regulatory changes. Taxes or exchange controls can be imposed suddenly. Assets could be compulsorily re-acquired without adequate compensation. The price per Share of all Share Classes is quoted on a forward-pricing basis, and is normally available on the website <a href="https://www.fullertonfund.com">https://www.fullertonfund.com</a> within two (2) Business Days of the actual transaction dates and may also be available on Bloomberg and SIX Telekurs. You may also request for the indicative price per Share from the Singapore Representative. **APPENDIX: GLOSSARY OF TERMS**

<b>ABS / MBS</b>	Asset backed securities (ABS) and mortgage backed securities (MBS) are debt securities based on a pool of assets or collateralised by the cash flows from a specific pool of underlying assets.	
<b>Bond Connect</b>	A new initiative launched in July 2017 for mutual bond market access between Hong Kong and China.

<b>Business Day</b>	A week day on which banks are normally open for business in Luxembourg and Singapore.
<b>CIBM</b>	The China interbank bond market.
<b>CoCos</b>	Contingent convertible securities.
<b>Dealing Day</b>	A Business Day which does not fall within a period of suspension of calculation of the NAV per Share of the Fund and such other day as the directors of the Company may decide from time to time.
<b>emerging and less developed markets</b>	Countries with emerging and less developed markets include, but are not limited to (1) countries that have an emerging stock market in a developing economy as defined by the International Finance Corporation, (2) countries that have low or middle income economies according to the World Bank, and (3) countries listed in World Bank publication as developing.
<b>EPM</b>	Efficient portfolio management.
<b>FDIs</b>	Financial derivative instruments, which may include but are not limited to options on securities, OTC options, interest rate swaps, cross currency swaps, credit default swaps, futures, currency forwards, contract for difference, credit derivatives or structured notes such as credit-linked notes, equity-linked notes and index-linked notes.
<b>Fund Currency</b>	The reference currency of the Fund.
<b>NAV</b>	Net asset value as determined in accordance with the Singapore Prospectus.
<b>Non-investment grade</b>	In respect of fixed income or debt securities, means a security with a long-term credit rating of below BBB- by Standard & Poor's, Baa3 by Moody's, or BBB- by Fitch (or their respective equivalents).
<b>OTC</b>	Over-the-counter.
<b>p.a.</b>	Per annum.
<b>QFI</b>	A Qualified Foreign Investor pursuant to the relevant PRC laws and regulations.
<b>QFI Eligible Securities</b>	The securities and investments permitted to be held or made by QFI Regulations.
<b>QFI Regulations</b>	The laws and regulations governing the establishment and the operation of the qualified foreign investors regime in the People's Republic of China as may be promulgated and/or amended from time to time.
<b>RMB</b>	Renminbi, the official currency of the PRC, is used to denote the Chinese currency traded in the onshore and the offshore markets (primarily in the Hong Kong Special Administrative Region) - to be read as a reference to onshore Renminbi (CNY) and/or offshore Renminbi (CNH) as the context requires. For clarification purposes, all references to RMB in the name of a Share Class or in the reference currency must be understood as a reference to offshore RMB (CNH).
<b>Shares</b>	Shares in the Fund.
<b>Share Class</b>	Class of Shares in the Fund.
<b>SICAV</b>	Société d'Investissement à Capital Variable, being an investment company with variable capital that is established in the Grand-Duchy of Luxembourg. Fullerton Lux Funds qualifies as a SICAV under Part I of the Luxembourg law of 17 December 2010 relating to undertakings of collective investment.
<b>UCIs</b>	An "other undertaking for collective Investment" which

	is not subject to the provisions of Council Directive 2009/65/EC of 13 July 2009.	
<b>UCITs</b>	An "undertaking for collective investment in transferable securities" within the meaning of article 1(2) of Council Directive 2009/65/EC of 13 July 2009.
