#### WHO IS THE PRODUCT SUITABLE FOR?

- The Sub-Fund is only suitable for investors who:

  - are comfortable with the risks of a fund which invests primarily in SGD denominated fixed income or debt securities issued by the Singapore government, government agencies, quasi-government institutions, statutory boards and corporations; and
  - are comfortable with a single country fund.

### KEY PRODUCT FEATURES

#### WHAT ARE YOU INVESTING IN?

- You are investing in a sub-fund of an umbrella unit trust constituted in Singapore. The Sub-Fund aims to generate long-term capital appreciation for investors by investing primarily in fixed income or debt securities denominated in SGD. These securities will primarily be issued by the Singapore government, government agencies, quasi-government institutions, statutory boards and corporations.
- Distributions (if any) may be declared in our absolute discretion and may reduce the Sub-Fund's NAV.

### Investment Strategy

- We seek to add value from the following sources: interest rate accruals, selection of bonds and/or credits and duration management (optimisation of bond returns by selecting bonds with different terms to maturity).
- The Sub-Fund will primarily invest in investment grade issues. However, non-rated SGD issues are permitted if they meet our internal equivalent rating of investment grade.
- The Sub-Fund may also invest in other Authorised Investments, including securities issued by non-Singapore entities.
- We may use FDIs for hedging and EPM purposes (namely, managing risks) without leveraging the portfolio.

<b>HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?</b> <ul style="list-style-type: none"><li>You can exit the Sub-Fund on any Dealing Day by submitting a realisation form to us, either directly or through the agent or distributor from whom you subscribed for your Units.</li><li>First-time investors may cancel subscription of Units within 7 calendar days from date of subscription by submitting the Notice on Cancellation Form. You may do so without incurring the preliminary charge and fees stated above. However, you will be exposed to price changes in the NAV of the Sub-Fund since your subscription and will need to pay any bank charges, administrative or other fee imposed by the agent or distributor.</li><li>You will usually receive the realisation proceeds within 7 Business Days after your realisation request is received and accepted by us.</li><li>If you submit the realisation form by 5pm on a Dealing Day, you will be paid a price based on the NAV per Unit of the relevant class as at the Valuation Point. Authorised Investments	The definition of Authorised Investments is set out in Clause 1.1 of the trust deed relating to the Sub-Fund. Relating to this, you should also consider the definitions of Quoted Investment, Unquoted Investment, Investment and Cash as stated in that clause.																								
Business Day	Every day (other than a Saturday, Sunday or public holiday) on which commercial banks are open for business in Singapore or any other day as the Managers and the Trustee may agree in writing.																								
Dealing Day	In connection with the issuance, cancellation and realisation of Units, means every Business Day in Singapore.																								
EPM	Efficient portfolio management.																								
FDIs	Financial derivative instruments, which may include (but not limited to) options on securities, over-the-counter options, interest rate swaps, credit default swaps, futures, currency forwards, contract for difference, credit derivatives or structured

<b>NAV</b>	In relation to the Sub-Fund, the value of all assets of the Sub-Fund less liabilities or, as the context may require, of a Unit of the Sub-Fund, determined in accordance with the provisions of the trust deed relating to the Sub-Fund.

<b>Units</b>	Units in the Sub-Fund.
<b>Valuation Day</b>	The relevant Dealing Day or such other day as we may determine (with the prior approval of the Trustee) upon one month's prior notice of the change being given to the Holders.
<b>Valuation Point</b>	The close of business of the last relevant market to close on the relevant Valuation Day on which the NAV of the Sub-Fund or class of its Units is to be determined for a Dealing Day (or such other time as we may determine), subject to the Trustee's prior approval and (if required by the Trustee) providing notice to the Holders.
